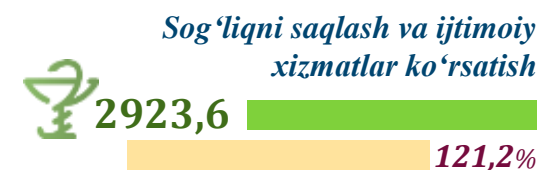

2022-2023 - yillarda o'rtacha oylik ish haqining oylar kesimidagi dinamikasi, ming so'm



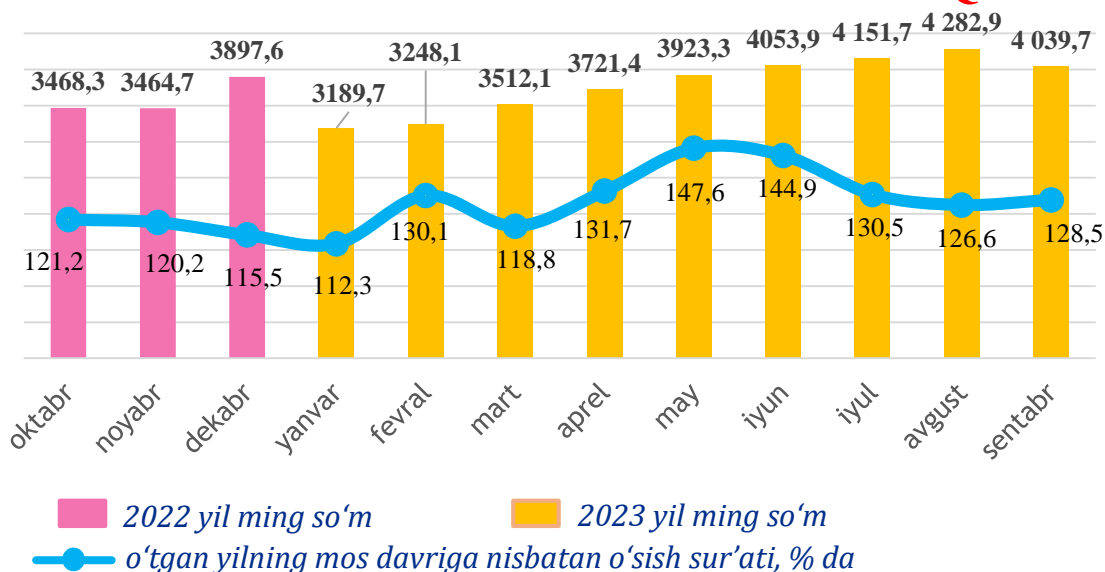
Iqtisodiy faoliyat turlari kesimida o'rtacha oylik ish haqi, ming so'm



2023 - yil yanvar - sentabr oylarida iqtisodiy faoliyat turlari bo'yicha o'rtacha oylik ish haqining eng baland ko'rsatkichi – qurilish sohasiga to'g'ri kelib, o'tgan yilning mos davriga nisbatan o'sish darajasi **94,1 %** ni tashkil etdi.

Shuningdek, axborot va aloqa sohasi **64,9%**, tashish va saqlash sohasi **53,1%**, sanoat sohasi **29,1 %**, Bank, sug'urta, lizing, kredit va vositachilik faoliyati sohasida **22,9 %** sog'liqni saqlash va ijtimoiy xizmatlar ko'rsatish sohasi **21,2%**, ga o'sganligini ko'rishimiz mumkin.

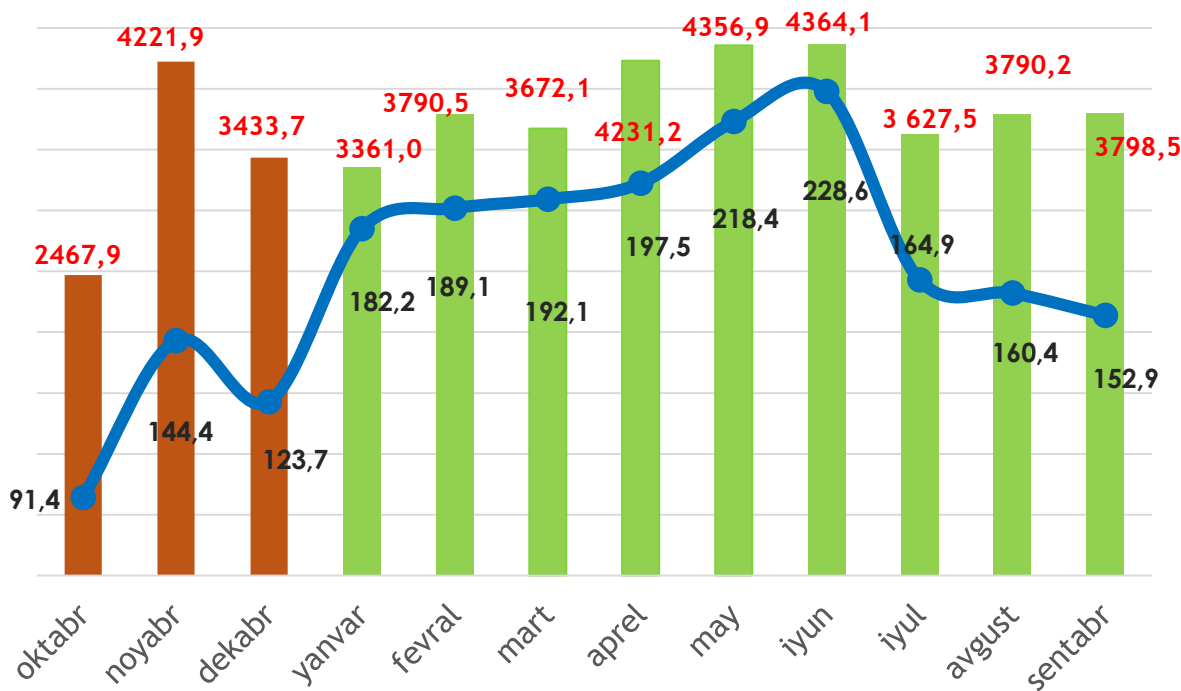

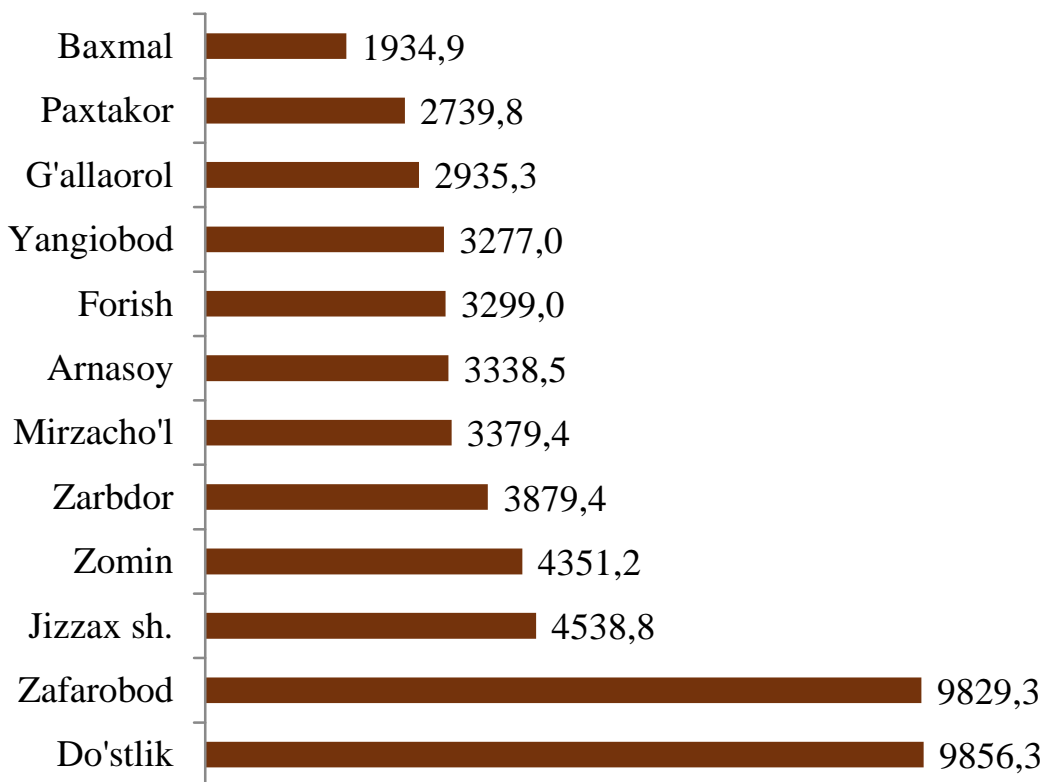

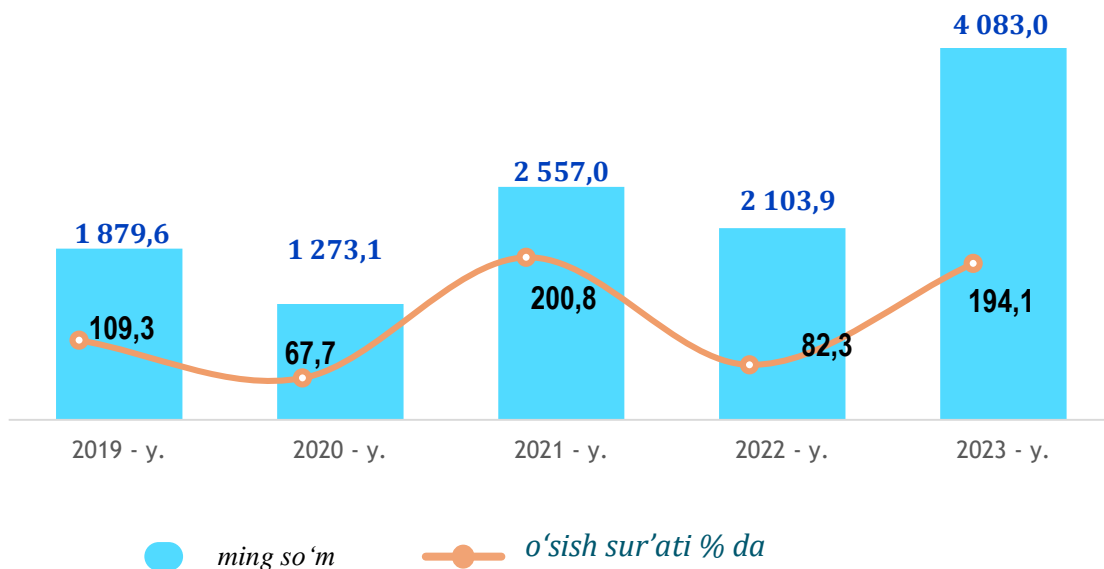

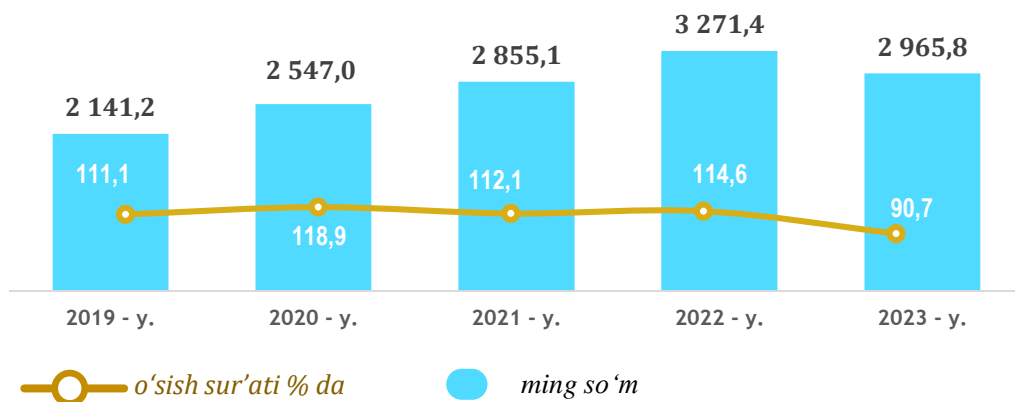

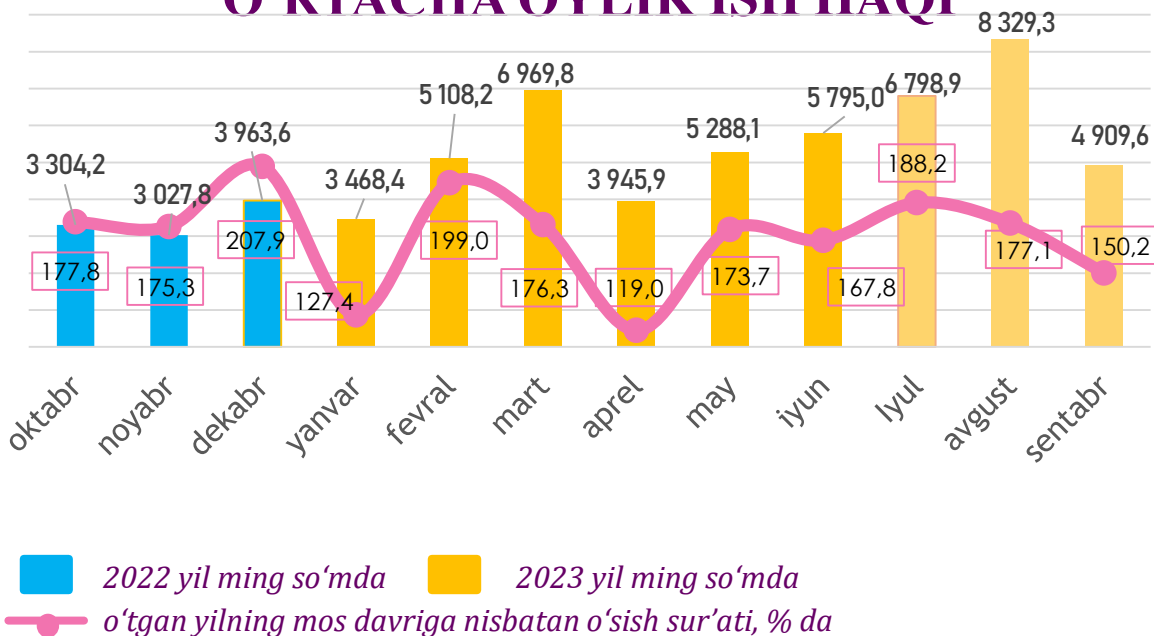

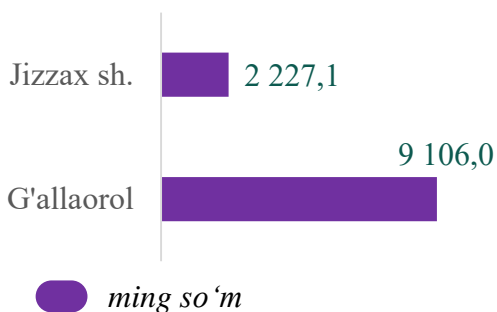

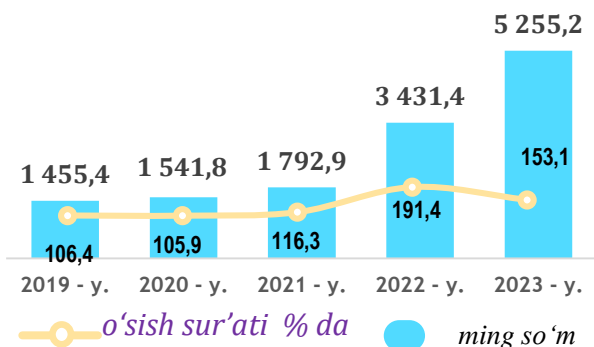

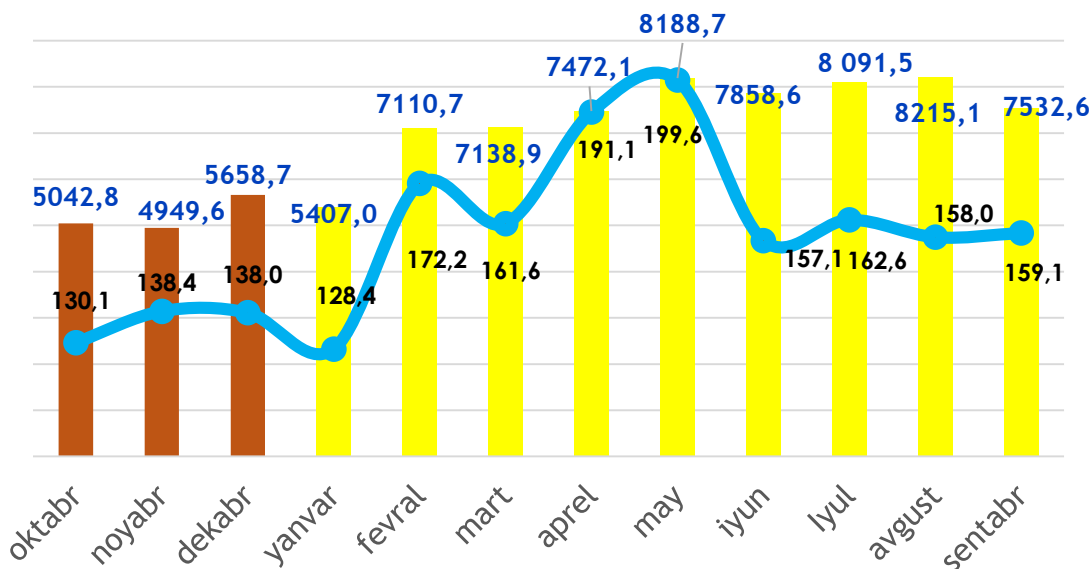

AXBOROT VA ALOQA SOHASIDA O'RTACHA OYLIK ISH HAQI

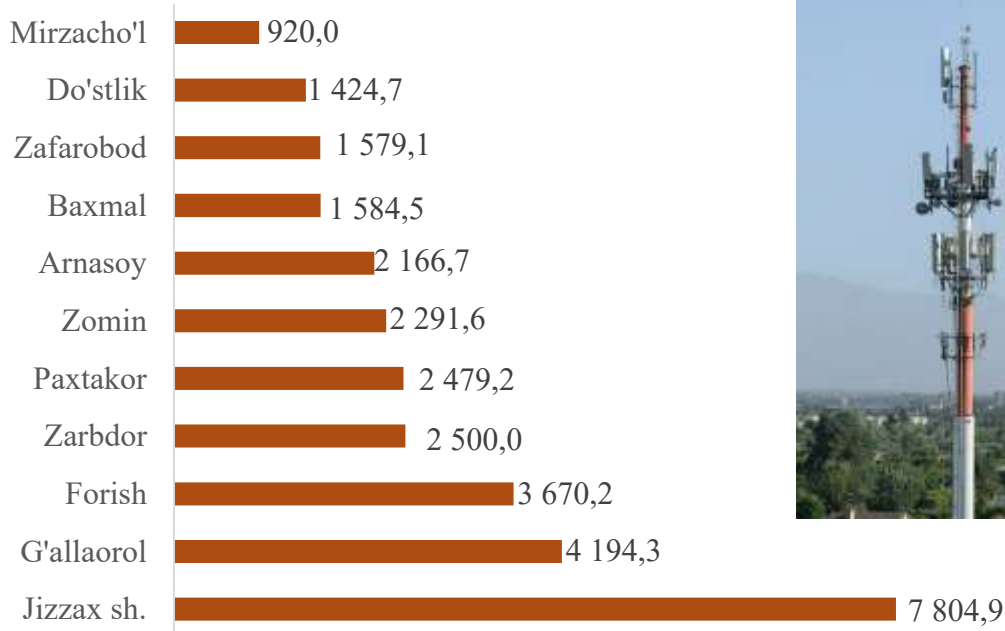

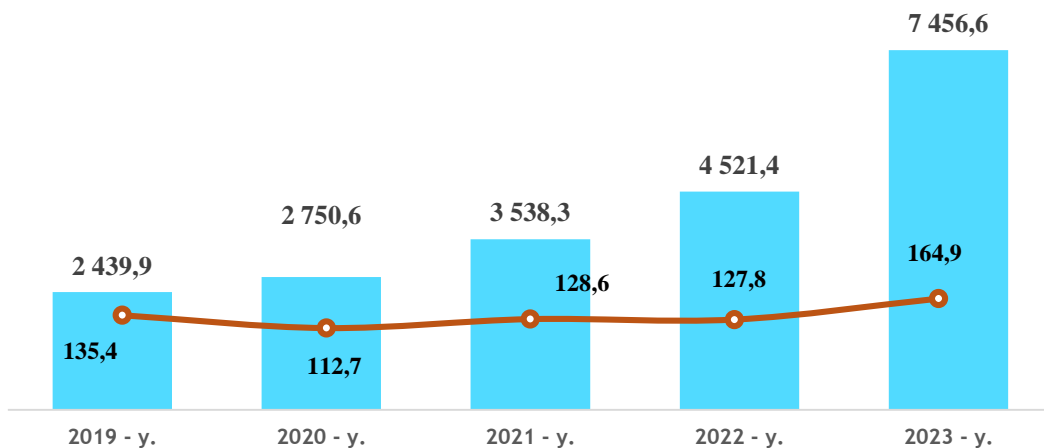

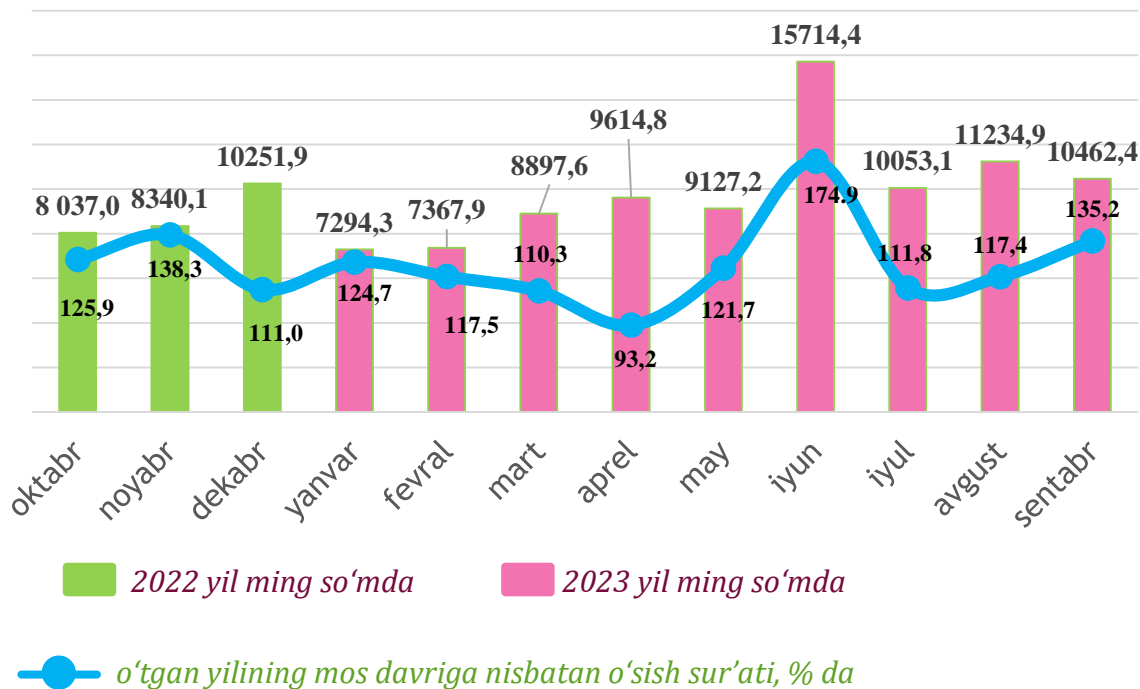

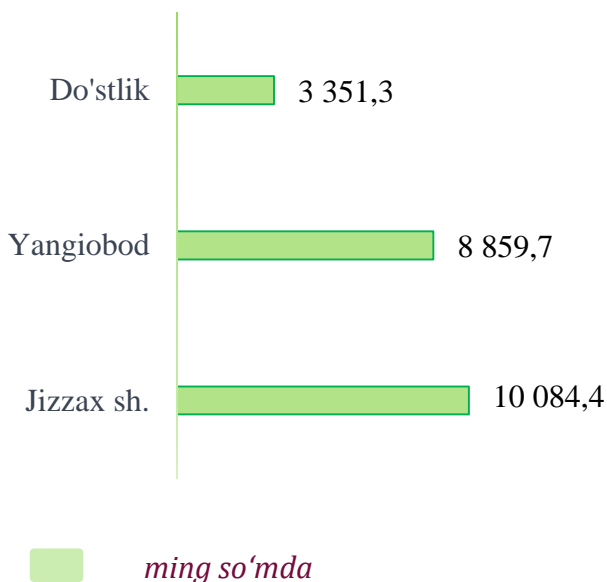

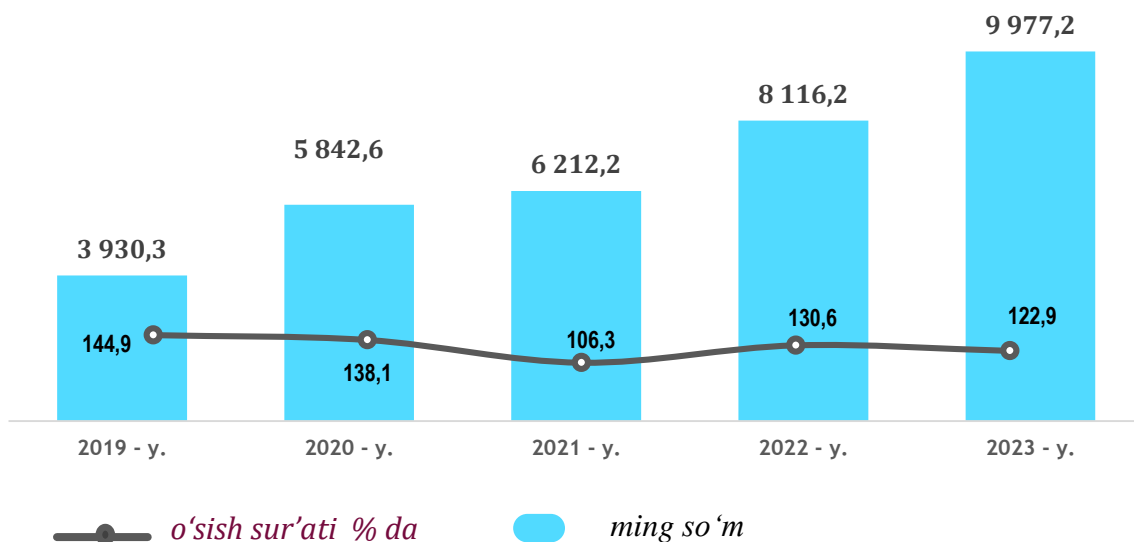

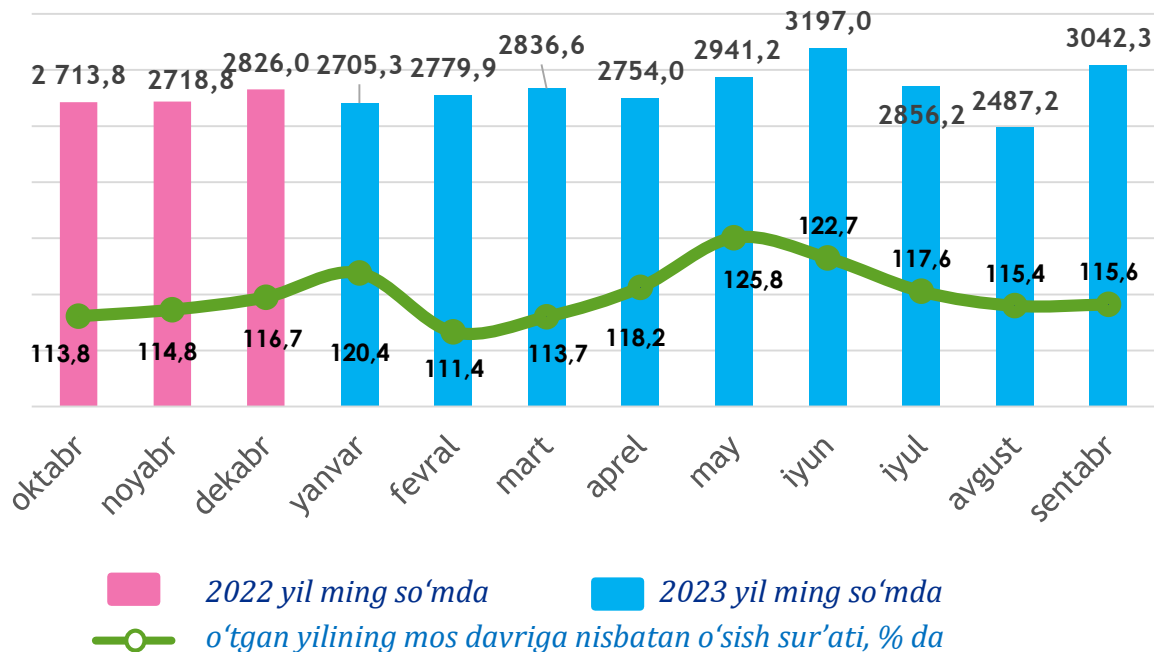

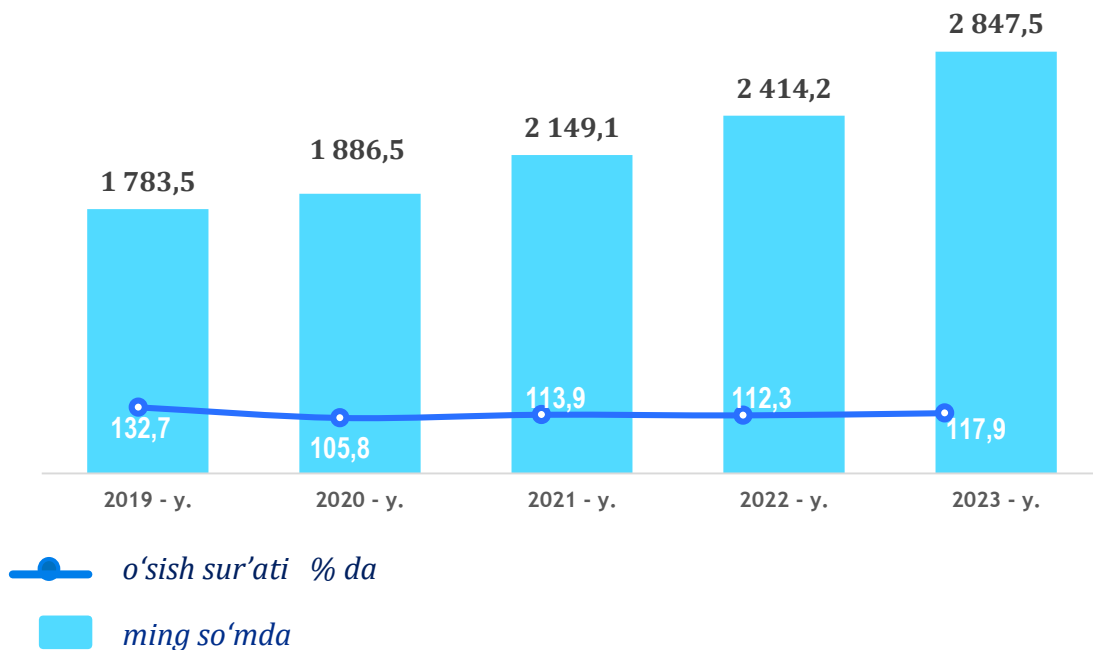

TA'LIM SOHASIDA O'RTACHA OYLIK ISH HAQI



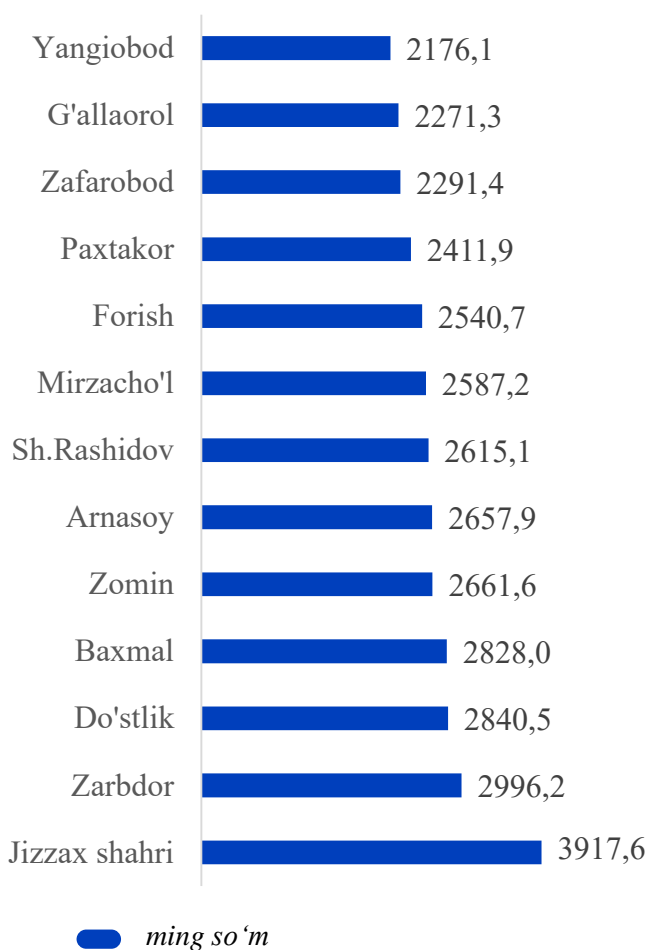

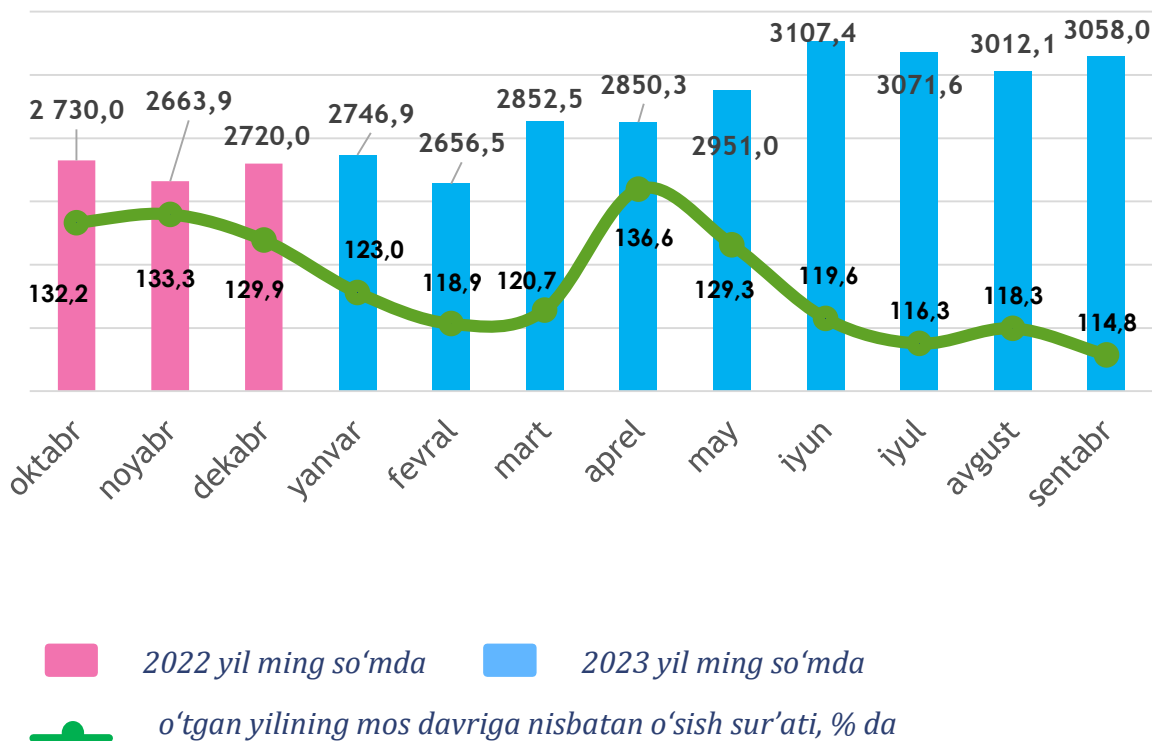
